

IX0700: Toy Management

1.0 PURPOSE

To prevent transmission of microorganisms from toys to patients, siblings and families.

2.0 GENERAL PRINCIPLES

- **2.1.** Encourage families to bring some of the child's favourite toys from home and keep at the child's bedside labelled with the child's name.
- **2.2.** Playrooms and play areas should have:
 - access to both alcohol based hand rub (ABHR) and a hand wash sink
 - have an area or bin to place used toys in
 - someone assigned to clean and disinfect the toys and area daily
- 2.3. Toys should be nonporous with a smooth/non-textured surface for easy cleaning.
- **2.4.** Stuffed toys and water-retaining bath toys are not to be used.
- **2.5.** For patients on Additional Precautions, assign toys, books, or electronic games to the patient, then clean and disinfect the toys upon discharge or when precautions are discontinued.
- **2.6.** Shared electronic games and computers should be cleaned between users.
- **2.7.** In waiting rooms limit supply of shared books, magazines and cards and discard when visibly soiled.

3.0 PROCEDURE

- **3.1.** Hand hygiene:
 - Must be done before and after playing with toys
 - Assist children to clean their hands with ABHR or soap and water
- **3.2.** Inspect toys for damage, cracks or broken parts and discard.
- **3.3.** Toys must be cleaned prior to disinfection:
 - Wash toys with regular soap and water using friction
 - Rinse with water and dry
 - Toys assigned to patients must be cleaned when visibly soiled and once per week
- **3.4.** Disinfection options:
 - Use a dishwasher (must reach 82° C for 10 seconds)
 - Wipe toys with hospital approved disinfectant allow appropriate contact time, then rinse with water and dry



• **Phenolics** must not be used for toys or equipment that comes into contact with infants
