## Public Health Act (PHA) & Pool Regulation (PR) - Enforcement Action

The Pool Regulation governs the construction and use of all commercial and public pools in British Columbia, which include swimming pools, hot tubs, and spray and wading pools. Public Health Engineers conduct design approval and Environmental Health Officers issue operating permits and monitor the use and maintenance of pools under the Regulations through inspection and sampling activities.
