## FREQUENTLY ASKED QUESTIONS

Can I set up a preauthorized payment plan for my bills?

Yes. This can be arranged by contacting our office.

I need a yearly receipt of payment. Where do I obtain this?

Your monthly rate is based on your most recent tax assessment. Upon admission, the Case Manager for your facility will complete a financial assessment and determine a monthly billing rate. Only this rate is forwarded to our office.
