Rabies Post Exposure Prophylaxis (RPEP)

Rabies exposure season is here with an increased opportunity for contact with bats and other wildlife. It is important to ensure that patients get the necessary assessment and treatment following an animal contact (bite, scratch etc.) at an emergency department to determine whether RPEP is required. Only a Medical Health Officer can release RPEP (rabies immunoglobulin and rabies vaccine).

New pre-printed orders and a fillable, submittable RPEP Reporting form are being developed to assist emergency departments with managing animal contacts for RPEP and to facilitate the hand-over to public health. It is expected these will be rolled out in beginning of July.

Shorter Adverse Events Reporting Form

Health care providers including physicians and pharmacists are required by law to report Adverse Events Following Immunization (AEFI) to monitor vaccine safety. Community vaccine providers can complete this 2-page, fillable <u>Report of AEFI form</u> and fax 250-549-6310 or email <u>AEFIReporting@interiorhealth.ca</u>.


