AQ0100 - ARCHITECTS, ENGINEERS AND QUANTITY SURVEYORS, USE OF

1.0 PURPOSE

To provide guidelines for Interior Health to authorize engaging the use of Consultants.

2.0 DEFINITIONS

Consultants:

includes Architects, Engineers and Quantity Surveyors who provide Interior Health with assistance for consultative and/or design services relating to effective use of facilities, space planning, master planning, functional programming, feasibility studies, cost estimating, etc. for minor/major capital projects.

3.0 POLICY

Interior Health may engage Consultants to provide services in the following areas:

- consultative work related to effective use of facilities, space planning, master planning, functional programming, feasibility studies, cost estimates, etc.
- design work related to capital projects
- · design work related to operating projects.
- preparation of cost estimates for capital and operating projects
- Engaging Consultants must be done through the Capital Planning & Projects (CPP),
 Plant Services or IMIT Departments. Authority to engage the consultants must be in accordance with the approved <u>Interior Health Signing Authority Policy</u>.

A competitive procurement and selection process is to be implemented to evaluate and select consultants. Use of a Request for Proposal and approved standard industry client agreements are required when engaging Consultants. The terms and conditions for engagement and services required must be set out in advance of engagement of the Consultants.

4.0 PROCEDURE

Contact the appropriate Corporate Director (CPP, IMIT, Plant) prior to engaging Consultants.
